

**RELEASE, WAIVER AND INDEMNITY AGREEMENT**

I do hereby acknowledge that \_\_\_\_\_, under a Hunting License commencing \_\_\_\_\_, has given me permission to hunt and/or fish and/or otherwise be present on certain lands (hereinafter referred to as the "Property") owned or managed by **TENSAW LAND & TIMBER COMPANY, INC.** ("Licensor").

**I execute this Release, Waiver and Indemnity Agreement ("Agreement") in consideration for this permission and in recognition of the fact that the Licensee is prohibited from extending this permission to me unless I agree to the matters set forth in this document.**

I ensure that I will have my guests or invitees on the Property sign a copy of this Agreement, and understand that any guest who does not execute a release will be asked to leave the Property immediately. I will assume full responsibility for the actions of any guest if I fail to have them execute a copy of this Agreement.

I understand that this permission may be revoked in writing by Licensee or Licensor at any time.

This Agreement is in effect during the time that I am permitted on the Property or other hunting properties managed by Licensor, now and in the future, and until this Agreement is revoked in writing.

I agree to comply with all applicable statutes, ordinances, regulations and other laws while on or in the vicinity of said property, including, but not limited to, those pertaining to hunting and fishing.

**I acknowledge that hunting, fishing and activities related thereto are inherently subject to certain dangers and risks. I hereby assume all such risks and dangers.**

I agree that Licensor has no obligation to eliminate or reduce any such dangers or risks or to provide a safe place in connection with my hunting, fishing and related activities on the property.

I further release, and will indemnify and hold harmless, Licensor, in both its corporate and representative capacities, and Licensor's officers, employees, agents and contractors, from and against any and all claims for injuries to me (including injuries causing my death) or damage to my property that I may sustain while on said property or engaged in any activities associated therewith, including any such claims that may arise (in whole or part) from the alleged or actual negligence or other fault of Licensor in any of its capacities or of any officer, employee, agent or contractor of Licensor (whether such alleged or actual negligence or fault be active, passive, sole, concurrent or due to an actual or alleged breach of any statutory duty).
